COMPANY PROFILE

2015, 50 companies were listed on the exchange. Being in the stock market industry, they deal with a lot of confidential data in the premises. Video Surveillance, here, plays an important role of protecting the confidentiality of data along with security of staff and visitors.



REQUIREMENT

- They wanted to migrate from Analog to IP solution for monitoring key zones.
- They needed three month storage period as evidential proof.
- Security officer, IT manager and admin were required to view selected cameras for remote monitoring.
- They wanted motion based recording, where the degree/severity of motion varied from zone to zone.

CHALLENGE

- High cost of HDD for storing recordings of 46 cameras for three months.
- Their building was made out of glass. Hence, continuous light from outside created reflection inside the premise. This was identified as motion by the camera and it initiated recording each time there was a reflection, which resulted in unnecessary increase of storage requirement.
- Securing confidentiality of data in real-time, rather than investigating at a later stage.



MATRIX OFFERING

HVRs were installed so as to facilitate easy migration from Analog to IP. On complete migration to IP, these HVRs have the capability to function as NVRs without any hardware changes.

Adaptive Recording feature was enabled to reduce storage requirement by 50%.

Advanced Storage Management in Matrix HVRs helped them to schedule three months backup of all cameras centrally. This also helped them to smartly optimize their storage by providing regular clean-up options in two ways:

- 1. Delete backed up files after every backup.
- 2. Delete files older than the specified number of days (three months).

Cascading feature helped them in viewing cameras from all three HVRs on TVs in the control room for central monitoring, without any server.

Motion detection, with the flexibility of area selection and sensitivity selection, helped them prevent unnecessary recording in case of motion arising due to lights from certain zones.

Timely notifications in case of motion detection helped secure assets in real-time.

User based login credentials for security officer, IT manager and admin was configured to allow viewing of selected cameras.

Matrix also provided efficient pre and post-sales support as a part of the solution.
